Dear Redistricting Task Force,

The West of Twin Peaks Central Council (WTPCC) is a registered non-profit Neighborhood organization representing a community of interest of 20 homeowner and neighborhood improvement associations. 18 of our 20 member organizations are contained wholly in the current District 7. Pinelake Park Neighborhood Association is in District 4, and parts of the Twin Peaks Improvement Association are in Districts 5 and 8.

The WTPCC formed in 1937 and has been representing the common interests of our member organizations for the past 75 years. Delegates from each of our member organizations meet monthly under the umbrella of the WTPCC to address issues of mutual concern, and each of our member organizations have monthly or quarterly meetings of their dues paying members (See the attached list of WTPCC member organizations).

The neighborhoods WTPCC represent were mostly built between 1912 and 1950 and are primarily composed of owner-occupied, single-family homes. Our residents choose to live here because it is a medium-density area that provides space for yards and children, as well as local commercial shopping districts and recreation options and parks. Cumulatively, we have a shared history of protecting and improving the shared characteristics and the character of our neighborhoods.

The WTPCC Redistricting Committee is very concerned about the possibility of having our voting power diluted by moving seven (7) of our member organizations into adjoining districts. Visualization 7, published by the Task Force does just that – moving the Forest Knolls, Midtown Terrace, Mount Sutro Woods, The Woods and the rest of the Twin Peaks Improvement Association neighborhoods into District 8, and Lakeshore Acres and Merced Manor neighborhoods into District 4.

We believe there are ways of achieving the goals of balancing the district populations without splitting the WTPCC member organizations and portions of our established neighborhoods off into separate districts, or deviating from established geographic boundaries. We are therefore submitting our own map of our community of interest and our neighborhoods that follow long-established geographic boundaries. This map achieves the goals of: 1) Balancing the district population to within 0.02% of the mean population for the new districts, 2) Placing all WTPCC member organizations in District 7, and 3) Unifies the Ocean Ave. commercial corridor in District 7.

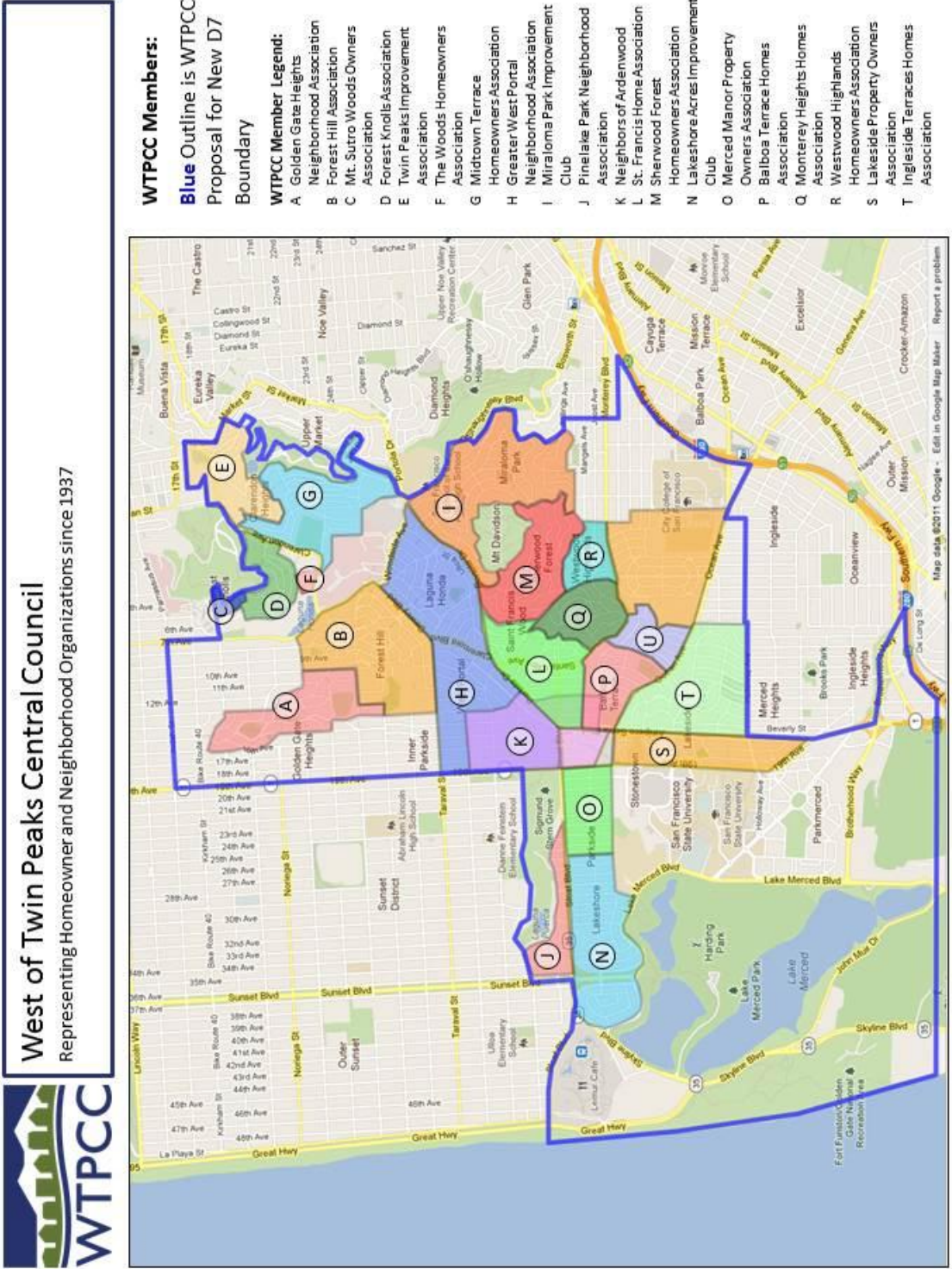
