Meeting called to order: 7:37 pm

Minutes: March 23 2010 minutes were approved by unanimous vote.

Treasurer's Report: Carolyn Squeri reported that there is \$ 3875.78 in the Treasury.

Committee Reports: Health, Communications and Events, no report

Traffic & Safety: Avrum Shepard reported that a 90-day pilot program to activate parking meters on Sunday from 10 am to 6 pm was planned for West Portal Avenue and 5 other City commercial districts. The program's purpose is to gather data to determine if Sunday meters will benefit local businesses by increasing turnover in parking spaces. Sean Elsbernd announced he opposes Sunday parking meters because people will go to where parking is free and local merchants will not benefit. Avrum reported that white plates placed in street parking places will transmit data to a central location to report on length of stay of cars and the data will be used to set meter rates & eventually to alert traffic cops where cars have extended meter times.

Land Use and Planning: Matt Chamberlain reported that controversial changes to the Discretionary Review process have been shelved for now by the BOS Land Use Committee, but more "agreeable" changes are being considered. The Plg. Dept will hear public comment on these issues on May 6 and May 10 at 1640 Mission St..

New Business: George Wooding announced the nominating committee for the 2010-2011 slate will include, Dave Bisho, Don Dutil, Paul Conroy, and George Linn. The slate will be announced at the May 24 meeting and voted on

June 28 Annual Meeting. Elliott Wagner of West Portal merchants announced a Sidewalk Fair on May 15 on West Portal Ave. George Wooding reported that he and Vice President Don Dutil will be absent at the May 24 meeting and Treasurer Carolyn Squeri will conduct that meeting.

Featured Speakers: Sean Elsbernd reported about legislation he wants to put on the November ballot by way of a voter signature campaign. The legislation will remove language in the City Charter regarding the way MUNI drivers wages are determined. At present drivers are guaranteed a salary between the highest and second highest paid driver wage in the country. George Wooding moved that WTPCC support the Elsbernd legislation. Karen Breslin seconded the motion that was passed unanimously. Carmen Chu spoke in opposition of a proposed Medical Cannabis Dispensary (MCD) on Taraval Street citing its proximity to schools, Taraval L MUNI line, a church and a shelter for women. There have been 2000 signatures gathered in opposition of the Taraval St. MCD. Myong Leigh and Orla O'Keefe spoke in favor of Prop A on the June ballot that will extend a parcel tax for another 20 years to fund retrofit and other projects in public schools. The parcel tax will add about \$32.20 to residential and commercial properties
